PARTIAL TERMS AND CONDITIONS

1. Payment must be made in full at the time of purchase. Full terms and conditions of purchase for the Lot conveyed herein are detailed in "Purchase Terms and Conditions for Grave Plots and Exclusive Rights of Interment"

2. Purchaser understands that Lorneville & Seaview Cemeteries Inc. shall have the right to establish and amend Rules and Regulations from time to time, and agrees that all such provisions contained therein shall be incorporated herein by reference and made a part hereof. **Purchaser agrees to comply with established Rules and Regulations and provide annual tax deductible donations for future maintenance of the lots & grounds.**

3. A maximum of 4 interments shall be allowed in each grave plot conveyed herein –either up to four cremain interments **OR** up to three cremain and one casket interment. **NOTE: If the first interment is a cremation, a casket burial will not be allowed.**

4. The purchasers or their heirs and assigns agree that in the event that they wish to sell the plots purchased herein, they shall sell such lot or plots back to Lorneville & Seaview Cemeteries, at the same price for which the sale was originally made. No sales to third parties will be allowed.

5. Only the purchaser, the purchaser's spouse, their designated lineal descendants, or ascendants and family members, may be interred in the lot or lots conveyed herein. The persons designated in section 6 below may be interred in the subject plots.

6. The location in the Lot of the remains of the purchaser(s) and of those designated to be interred in the Lot conveyed herein, are to be noted on the attached Lot plan.

7. The purchaser(s) herein agree that they shall keep Lorneville & Seaview Cemeteries Inc. apprised of any changes in contact information provided on the LOT OWNER'S INFORMATION form and in any changes in those persons designated to be interred in the lot conveyed herein.
